## REVIEW FEES

*Effective 2008*

### **Initial Review by Full Board for:**

**Studies with One Principal Investigator - \$1200.00**

Each Additional Principal Investigator - \$500.00

**Planned Emergency Research Requesting Informed Consent Waiver with One Principal Investigator - \$2500.00**

Each Additional Principal Investigator - \$1250.00

### **Initial Review by Expedited Procedures for Studies with One Principal Investigator - \$500.00**

Each Additional Principal Investigator - \$150.00

(This provides a review, when appropriate, by the Chairman or an appointed member.)

### **Major Modifications - \$675.00**

This covers major changes to the protocol (such as extension studies submitted as amendments to the current protocol) or events requiring full board review. *(Additional fees may be charged per site for multi-site studies.)*

### **Minor Modifications - \$250.00**

This covers minor changes to the protocol qualifying for expedited review. *(Additional fees may be charged per site for multi-site studies.)*

### **Revised Informed Consent Documents - \$200.00**

### **Informed Consent Document Development - \$350**

### **Review of Interim Status Reports or Annual Review for Re-Approval - \$880.00 (Full Board); \$250.00 (Expedited)**

The frequency of Interim Status reports will depend on the risk level assigned by Fox Commercial IRB.

### **Final/Closeout Review - \$440.00 (for studies initially reviewed by Full Board); no charge (for studies initially reviewed by Expedited Procedures)**

### **Miscellaneous Fees**

**Advertisements (new or revised) - \$100 per advertisement**

**Administrative Letters (such as sponsor requested policy statements) - \$50.00**

**HIPAA Waiver (if submitted after initial review) - \$200.00**

**Non-Significant Risk Device Decision - \$350.00 (in addition to initial review fee)**

**Additional Sub-investigators/Sites (after the first three) - \$100 per submission**

**Determination of Waiver from IRB Review - \$350**

**Newsletters, Emergency Cards, Subject Information Pamphlets, Participation Gifts - \$50.00 each**

**Revised Investigator's Brochures, Prescribing Information, Device Instructions for Use, IDE Progress Reports, Serious Adverse Events and IND Safety Reports are reviewed at no charge.**

*Applications withdrawn after distribution to the Board, the Chairman or a designated member will be charged at the established rate.*

A Late Charge of 2% will be charged when payment is not received by the date specified on the invoice and monthly thereafter.
